**Classroom: (attach a course syllabus providing a brief explanation of each required topic):** at a minimum, shall include topics related to the specific manufacturer's model of an ECD for which the officer is to be authorized to carry or use: nomenclature, characteristics, capabilities, limitations, maintenance, operational principles and technology, proper ECD use addressing; agency policy and procedures, agency and other protocols, judgment and decision making, legal considerations, physiological and psychological effects, target zones, side effects and individuals with an elevated risk, after-care measures, defensive measures, potential collateral occurrences, safety of transport, storage and use. An officer shall achieve a minimum passing score of 70 percent on a written examination that tests the officer's comprehension of the above topics.

**Demonstrate Proficiency related to:** at a minimum requires an officer to demonstrate skills related to the proper use of the specific manufacturer's model of an ECD the officer is to be authorized to carry or uses as part of official duties; operational and functionality checks of the device, transition between a firearm and/or other tactical equipment and ECD, proper carrying and handling, loading and reloading (if applicable), restraint of an individual subjected to the device(s).

**Discharge Requirements (if the device is capable of discharging a projectile):** For each specific manufacturer's model of ECD the officer is authorized to carry or use the officer SHALL demonstrate discharging the device(s) or, in lieu of actual discharging, this requirement may be met by the ECD instructor discharging the device during a demonstration to two or more officers.

Permission to deviate from the required MPCTC ECD Program should be requested in writing (with explanation), and submitted with said program. MPCTC Regulations require that all ECD Instructors be certified by MPCTC and that their certification be current. It is not necessary to send any other documentation with this application, however, said documentation should be kept on file within said agency. **I certify that all information provided on this application is true and correct.**
