The 218th meeting of the Correctional Training Commission (CTC) was called to order by the Vice Chair, Director Ryan V. Ross, at 10:03 a.m. at the Public Safety Education and Training Center (Center), Sykesville, Maryland. A quorum was present.

The agenda and subsequent action(s) follow:

1. Call Meeting to Order

Director Ross called the meeting to order and asked all members, staff, and guests to introduce themselves.

2. Approval of Minutes from the January 18, 2024 Commission meeting.

Director Ross asked the members to review the minutes.

A MOTION to approve the minutes from the January 18, 2024 meeting was made by Deputy Secretary Harvey: SECONDED: Lt. Mobley

3. Training and Standards Report

Dr. Beskid directed Members to the new layout of the Training and Standards report. Ms. Brauning congratulated the agencies because the Certification Unit was able to send out compliance letters and cards for all agencies in the state except for 430 officers that are up for renewal in June. Dr. Beskid invited Ms. Cain, Mr. Martin, and Ms. Kershesky to include additional information about the report, they were no additional comments. The report was accepted with a unanimous vote of quorum.

4. Legal Issues

Assistant Attorney General Mayhew had no legal issues to present.

5. Old Business

a. COMAR 12.10.01.22 Discussion (Cannabis)

Language change proposed to strike COMAR 12.10.01.21(B)(2)(a)(b) COMAR as it relates to good moral character, thereby making 3, 2 and so forth. It was proposed to strike "and" and change to "or" of COMAR 12.10.01.22 (C)(1)(a).

A MOTION to adopt the proposed changes was made by Deputy Secretary Harvey: SECONDED: Lt. Barnett

b. Training for Background Investigators

Dr. Beskid informed the Commission that the training for Background Investigators will be vetted on April 12, 2024 at the Public Safety Education & Training Center.

c. Correctional Services Article

A subcommittee has been conducting a line by line review of the Correctional Services Article sections 8-209, 8-209.1, 8-209.2, and 8-210 as decided in the January meeting. The Commission was given a copy of the proposed revisions for review and comment. The subcommittee has met 6 times since the January meeting with no representation from the Department of Public Safety and Correctional Services due to non-participation from those that volunteered to be on the subcommittee. The importance of having representation from all agencies that will be affected by these changes was expressed by Dr. Beskid.

6. New Business

a. Mission Statement

Dr. Beskid proposed the idea of a mission statement for the Correctional Training Commission to have a mission statement that lets the public know what the Commission does. There was interest expressed to pursue a mission statement and Dr. Beskid will send an email to members ask follow up questions and an update will be provided at the next meeting.

b. Mandated employees and training requirements

i. Division of Parole and Probation (DPP) Specialized positions

Addictions Counselors are mandated employees based on job classification and required duties. This classification requires that they complete an academy, but it is not defined whether that is a Correctional Officer Academy or a Parole and Probation Agent Academy. DPP is requesting that these positions not have to go through and academy as COMAR 12.10.01.01.B.02 is unclear that Addictions Counselors for the Division of Parole and Probation are mandated according to the definition in COMAR and the belief is that DPP Addictions Counselors are exempt from being required to complete an academy. The Commission decided to table further discussion until a representative from DPP is present.

ii. Institutional Support Staff training objectives

The Commission agreed to table discussion for Commission staff to conduct further research in regards to COMAR addressing Institutional Support Staff training objectives.

c. Revisit Outstanding Projects

i. Contraband Summit

The idea of a Contraband Summit with state and local agencies to address contraband concerns was presented in April of 2022. Commission staff contacted Director Errol Etting, Intelligence and Investigative Division, DPSCS to discuss the plans from that meeting. Director Etting believes that the summit is still a good idea, but offered that having an annual contraband summit

to include state, local, and juvenile services. The commission would like to have both Director Etting and Commission staff to host an annual round table to address contraband concerns.

ii. Standardization of academy training for college credits

Discussion regarding whether the Commission is open to reigniting conversation with the Maryland Higher Education Commission (MHEC) about accreditation for correctional academies across the state to allow correctional professionals to earn college credit while in the academy.

Informational topics that were presented to the Commission without discussion; will be added to future meeting agendas.

- SB 402 passed which will affect the regional representation of the Commission membership.
- An audit revealed that private training providers were not meeting the training standards set forth by the Commission.
- Further review into all providers may be necessary to determine if others are not meeting the training standards.
- DPSCS through the Public Safety Education and Training Center (PSETC) has been approved by the National Institute of Corrections to be a host site for the Learning and Performance Coach, which is a 32 hybrid course open to state and local partners that are interested.

Director Ross announced that the Commission would hear the next item in Closed Session.

A MOTION was made by Lt. Barnett to adjourn to a Closed Session: SECONDED: Deputy Secretary Harvey. The MOTION carried.
