#### 2022 REPORT TO THE STATE OF MARYLAND

**January 1 – December 31, 2022** 

Each year in accordance with Public Safety Article §3-207(b) (1), the Maryland Police Training and Standards Commission (PTSC) collects information related to serious officer-involved incidents. During the 2022 General Assembly Session, several changes to the law were made which require additional information to be collected related to each serious officer-involved incident. The Police Training and Standards Commission made the required adjustments for calendar year 2022 reporting and developed a system by which law enforcement agencies report to PTSC, the number of serious officer-involved incidents each year, including for each incident:

- (i) the number of officers involved by race, ethnicity, and sex; (new)
- (ii) the number of officers disciplined by race, ethnicity, and sex; and (new)
- (iii) the type of discipline administered to each officer, by the officer's race, ethnicity, and sex. *(new)*

The PTSC approved the following definition of "serious officer-involved incident" at its January 3, 2018, meeting:

Incidents in which:

- (1) Criminal charges were filed against an officer; or
- (2) Complaints of criminal misconduct have been investigated and sustained against an officer; or
- (3) Complaints of excessive force have been investigated and sustained against an officer where the force resulted in serious injury or death of a person; or
- (4) An officer/person contact directly results in the serious injury or death of a person.

#### **REPORT MODIFICATIONS FOR 2022 REPORTING**

As a result of changes to the reporting requirements identified above, modifications were made to this report for 2022. In addition to the annual summary of agency reporting of the number of incidents and discipline, categories for race, ethnicity, and sex were added for the categories of: (i) officers involved, (ii) officers disciplined, and (iii) the type of discipline administered to officers. A new table has also been added that includes a five-year summary of incidents in order to identify any emerging trends.

The Maryland Police and Correctional Training Commissions' (MPCTC) staff developed a reporting process for agencies to report the required information. On January 10, 2023, agency heads were emailed an informational reporting guide and reporting link to a new Google Doc reporting system where the required data was entered by each agency and uploaded into a system maintained by MPCTC staff. Agencies were required to report the number of incidents for the following categories during calendar year 2022:

- (1) Direct officer contact that resulted in serious injury or death of the officer or person;
- (2) Complaints of excessive force which were investigated and sustained against an officer where the force resulted in serious injury or death of a person;
- (3) Complaints of criminal misconduct that have been investigated and sustained against an officer;
- (4) Criminal charges were filed against an officer.1

The Commission has also collected data on the following:

- (1) The number of officers involved by race, ethnicity, and sex;
- (2) The number of officers disciplined by race, ethnicity and sex; and
- (3) The type of discipline administered to each officer by the officer's race, ethnicity, and sex.

The types of discipline administered will be separated into the following categories:

#### Rank / Status Discipline

- Demotion
- Dismissal
- Resignation

#### **Monetary Discipline**

- Suspension
- Loss of Pav
- Loss of Leave

#### **Other Discipline**

- Written Reprimand
- Counseling
- Remedial Training

The last notable change to this report is the breakdown of data for each law enforcement agency reporting a serious officer-involved incident. This year 25 agencies (18% of mandated agencies) reported having at least one serious officer-involved incident for the 2022 calendar year.

#### 2022 LAW ENFORCEMENT AGENCY REPORTING

There were 157 agencies employing approximately 16,000 Commission- certified police officers in 2022. However, not all of the agencies were identified as being required to comply with Public Safety Article §3-207(b) (1) as some of the agencies have employees who are certified as law enforcement officers by the Police Training and Standards Commission but are not defined as law enforcement agencies under Public Safety Article §3-101(e). Therefore, a total of 136 agencies that were required to report officer discipline and serious officer incidents were identified for the 2022 reporting year. Agency heads received an email at the beginning of 2022 advising them of the process for submitting the required reports and follow-up emails and phone calls were made periodically to agencies that had not submitted by the May 1, 2023 deadline.

As of May 16, 2023, all required agencies submitted their Serious Officer-Involved Incident Reports. The cumulative totals for the reporting agencies are as follows:

The number of incidents reported for 2022 were fairly consistent in most categories compared to 2021 and the five year average. Sustained criminal misconduct complaints dropped 34% compared to 2021 and 25% below the five year average.
