INTRODUCTION

Pursuant to Public Safety Article §3-207(b)(1), the Maryland Police Training and Standards Commission (MPTSC) collects information related to serious officer-involved incidents. The statute specifically states:

(b)(1) The Commission shall develop a system by which law enforcement agencies report to the Commission each serious officer-involved incident each year, including for each incident:

- (i) the number of officers involved by race, ethnicity, and sex;
- (ii) the number of officers disciplined by race, ethnicity, and sex; and
- (iii) the type of discipline administered to each officer, by the officer's race, ethnicity, and sex.
- (2) The Commission shall annually summarize the information submitted by law enforcement agencies and:
 - (i) post the summary, excluding the names of officers and other involved parties, on a website maintained by the Commission; and
 - (ii) submit the summary to the General Assembly, as provided in §2-1257 of the State Government Article.

The MPTSC approved the following definition of "Serious Officer-Involved Incident" at its January 3, 2018, meeting. "Serious Officer-Involved Incidents," means incidents in which:

- (1) Criminal charges were filed against an officer; or
- (2) Complaints of criminal misconduct have been investigated and sustained against an officer; or
- (3) Complaints of excessive force have been investigated and sustained against an officer where the force resulted in serious injury or death of a person; or
- (4) An officer/person contact directly results in the serious injury or death of a person.

REPORTING PROCESS OVERVIEW

The Maryland Police and Correctional Training Commissions' (MPCTC) staff developed a reporting process for agencies to report the required information. On January 13, 2025, agency heads were emailed an informational reporting guide and reporting link to a Google Doc reporting system where the required data was entered by each agency and uploaded into a system maintained by MPCTC staff. Agencies were required to report the number of incidents for the following categories during calendar year 2024:

- Direct officer contact that resulted in serious injury or death of the officer or person;
- Complaints of excessive force which were investigated and sustained against an officer where the force resulted in serious injury or death of a person;
- Complaints of criminal misconduct that have been investigated and sustained against an officer;
- Criminal charges were filed against an officer.¹

The Commission has also collected data on the following:

- The number of officers involved by race, ethnicity, and sex;
- The number of officers disciplined by race, ethnicity and sex; and
- The type of discipline administered to each officer by the officer's race, ethnicity, and sex.

The types of discipline administered will be separated into the following categories:

Rank / Status Discipline

Demotion
Dismissal
Resignation

Monetary Discipline

Suspension Loss of Pay Loss of Leave

Other Discipline

Written Reprimand Counseling Remedial Training

Data collected from each reporting law enforcement agency was summarized by agency. A state-wide summary for 2024 is included, along with a summary table that includes the four prior years and five year average. This year 20 agencies (14% of mandated agencies) reported having at least one serious officer-involved incident for the 2024 calendar year.

The data included in this report was provided by each law enforcement agency and has not been verified by the Maryland Police Training and Standards Commission. Questions regarding the accuracy of data should be submitted directly to the agency in question.

¹ An officer may be charged multiple times causing the reported numbers to appear disproportionate.

2024 LAW ENFORCEMENT AGENCY REPORTING

There were 157 agencies employing approximately 16,000 Commission-certified police officers in 2024. However, not all of the agencies were identified as being required to comply with Public Safety Article §3-207(b)(1) as some of the agencies have employees who are certified as law enforcement officers by the Police Training and Standards Commission but are not defined as law enforcement agencies under Public Safety Article §3-101(e). Thus, a total of 138 agencies were required to report officer discipline and serious officer incidents for the 2024 reporting year. Agency heads received an email at the beginning of 2025 advising them of the process for submitting the required reports and follow-up emails and phone calls were made periodically to agencies that had not submitted their report by the April 4, 2025 deadline.

As of June 6, 2025, all but one of the required agencies submitted their Serious Officer-Involved Incident Reports. The Princess Anne Police Department failed to submit their report as required.

The cumulative totals for the 138 reporting agencies are as follows:

In 2024, all four categories in the five-year summary remained at or below the five-year average. There were three categories representing notable reductions in reported incidents. Complaints of excessive force which were sustained resulting in death or serious injury, complaints of criminal misconduct that were sustained against an officer, and criminal charges filed against officers all dropped in 2024 compared to 2023 and the five year average.

¹ Reported information is not sufficiently definitive to establish the number of officers who received criminal charges. This data is reflective of the number of total criminal charges placed and not adjudicated.
